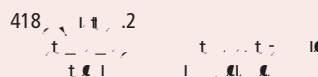

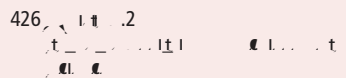

Multiple Comparisons of Average Achievement in Science Content Areas



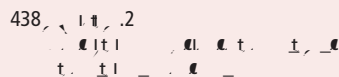
